The staff at the Tamarisk Coalition have been keeping busy with the lead-up to the 2007 Tamarisk Symposium, several GIS mapping projects, the U.S. Army Corps of Engineers 206 Project, and our volunteer program in the McInnis Canyons National Conservation Area.

2007 Tamarisk Symposium

The 2007 Tamarisk Symposium was held last week, October 24th-26th, at the Two Rivers Convention Center in beautiful Grand Junction, Colorado. This year's Symposium was a great success drawing over 260 participants from 15 States and from a wide range of disciplines including: land managers, federal and state agencies, landowners, key researchers, NGO's, and policymakers. The conference included a multitude of excellent, knowledgeable speakers, posters on current research, vendor booths, and a time to network.

The final day of the conference offered a chance to see a biological control release site with a field trip to Dewey Bridge along the Colorado River in Utah. Dr. Dan Bean, an entomologist from the Palisade Insectary, spoke about the tamarisk leaf beetle (*Diorhabda elongata*) in an area where the beetles have been heavily defoliating tamarisk over the last three years.
